

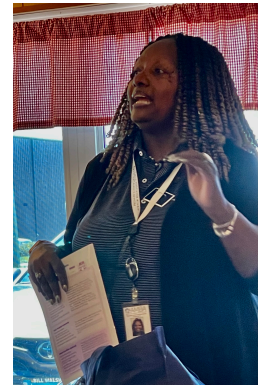
Grundy County Retired Teachers Association
